1. Introduction

This report presents the results of the impact evaluation of ComEd's Plan Year 9 (PY9) slate of energy efficiency programs offered under the Energy Efficiency Portfolio Standard (EEPS) and the Illinois Power Agency (IPA) umbrella. It presents a summary of the energy and demand impacts for the portfolio and each program and some detail on measure-specific savings. PY9 covers June 1, 2016 through December 31, 2017.

In PY9, ComEd's portfolio included programs implemented under the EEPS and IPA umbrella, pilot programs, and public sector and income eligible programs that ComEd took over from the DCEO portfolio on June 1, 2017. ComEd implemented 57 programs, including 25 EEPS, 22 IPA, and 12 DCEO bridge period programs, as listed in Table 1-1. This involved 23 programs in the residential sector (including Income Eligible programs) and 34 programs in the business sector (including public sector programs).

This summary report contains savings from 54 PY9 programs that final impact evaluation reports have been submitted to ComEd.¹ Process evaluation findings and results of net-to-gross research are presented in separate reports.

The AirCare Plus Program and Lighting Discounts Program had savings counting toward both EEPS and IPA targets. Those programs appear twice in the program level results shown below. The Lighting Discounts Program and Instant Discounts Program both had carryover savings from measures sold or incented in PY7 and PY8 that were installed in PY9. The PY9 Instant Discounts program carryover savings were attributed to the EEPS portfolio. The PY9 Lighting Discounts program carryover savings from PY7 were attributed to the EEPS portfolio, and the carryover savings from PY8 were attributed to the IPA portfolio.

¹ Three PY9 programs had no savings. These programs are: Root3 Energy Data Model, Low-Income Multi-family (UIC-ERC), and Total Connected Savings Wi-Fi Thermostat Optimization. These programs are shown in Table 1-1 but are excluded from subsequent tables containing program evaluation results.

2. Portfolio Savings

Table 2-1 summarizes the incremental energy and demand savings the ComEd portfolio achieved in PY9.

Table 2-2 summarizes savings from the EEPS, IPA and DCEO bridge period portfolios. In PY9, ComEd's energy efficiency portfolio achieved 2,368,290 verified net MWh savings, with the EEPS portion achieving 1,087,076 verified net MWh, the IPA portion achieving 1,245,732 verified net MWh, and the DCEO bridge programs achieving 35,482 verified net MWh. This included 2,310,412 net MWh from funded measures in PY9 and 57,878 net MWh savings from previously funded lighting measures, or carryover, funded in PY7 or PY8 through the Lighting Discounts Program and Instant Discounts Program and expected to be installed in PY9. Of the 57,878 MWh in total PY9 carryover savings, 37,103 net MWh was attributable to EEPS and 20,775 net MWh was attributable to IPA.




Figure 2-1. Energy Savings by Program Category

Overall, the IPA programs realized 53% of the portfolio savings and the EEPS programs had 46% while one percent came from DCEO bridge period programs. The IPA Residential programs contributed 40% of the total savings, followed by EEPS Business programs at 27% (see Figure 2-1). Further detail on the savings by program category are shown in subsequent sections.

3. SAVINGS BY PROGRAM

The savings by program are shown in the following tables and figures. Note that the AirCare Plus Program had savings counted toward both EEPS and IPA targets, and therefore appears twice in the tables. The Lighting Discounts Program had carryover savings counted toward both EEPS and IPA targets, while the Instant Discounts Program had carryover savings counted toward EEPS target.

4. SAVINGS BY MEASURE

Lighting measures contributed the most energy and demand savings to the portfolio by a substantial margin as shown in the end-use type categories in Table 4-1, Table 4-2, and Figure 4-1. Lighting measures contributed the most 53% of the portfolio savings in PY9. Behavioral programs follow with 30% of net savings with majority of savings from Business Energy Analyzer and Home Energy Reports.






Figure 4-2. Net Peak Demand Savings by End-use Type
