



Residential Program Highlights

- Launched virtual and low-touch offerings for Single Family and Multi-Family programs
 - ✓ Virtual Home Energy Jumpstart
 - ✓ Self-Installation for Multi-Family
- No- and low-cost measure installation exceeded expectations
- Residential programs finished the year at 128% of goal for PGL and 90% of goal for NSG
- Implemented improved safety protocols
 - ✓Zero program related COVID-19 incidents







Income Eligible Program Highlights

- Distributed 22,000 energy-savings kits across PGL and NSG territories
 - Continued to reach customers with energy-saving measures in a no-touch fashion
- The Income Eligible Multi-Family PTA program served nearly 800 customers, exceeding our annual target by more than 300%
- Teams continued to engage with partners, customers, and vendors virtually to drive program awareness







Business Program Highlights

- Business programs achieved 123% of the PGL savings goal in 2020 despite COVID challenges
- The Small and Midsize Business
 Program hosted numerous virtual events to share energy-saving best practices, including a webinar specifically for hotels and restaurants
- The Commercial Food Service Pilot exceeded initial savings goal
- Delivered more than 800 energysavings kits to Small Businesses in NSG territory, specifically grocery stores, schools, offices and restaurants - markets hit hardest by COVID shutdowns







Public Sector Program Highlights

- Public Sector customers were greatly impacted by Covid-19
- Emphasized relationship building with public sector customers and increased the number virtual meetings with key customers to maintain engagement
- The Chicago Public Schools led the way in 2020 by continuing to safely engage in maintenance projects, establishing a cadence for performing regular projects, and developing a process for the program to directly pay Trade Allies for project implementation (a key barrier up to this point)
- Leveraged Gas Optimization Studies in the public sector to help customers identify large projects and multiple efficiency opportunities for 2021










PGL 2021 Portfolio Performance



Program Spend Compared to Budget











NSG 2021 Portfolio Performance















Peoples Gas Public Sector 2021 Outlook

Program Highlights

- Established regular meetings with building managers and energy management teams with CPS, Cook County, the City of Chicago and the CTA
- Conducting building surveys and ASHRAE audits to identify savings opportunities and estimated incentives
- Chicago Public Schools received a staffing grant to assist their team in implementing energy efficiency projects
- Cook County is completing their first ever projects with us this year
- We have paid 65% of our goal and are forecasting to overdrive participation in this sector in 2021

Program Updates

- Demand for rebates and incentives is high
- In order to manage to remaining budget, we have made modifications as follows:
- PGL:
 - ✓ Effective August 1, projects submitted through our Partner Trade Ally program for Small Midsize Business and Multi-Family Programs can no longer be accepted
 - Initiating a waitlist on any new Commercial and Industrial, Small and Midsize Business and Multi-Family projects submitted after August 31
- NSG:
 - Initiating a waitlist on any new Multi-Family projects submitted after August 31

Thank you for your participation in the Peoples Gas Small and Midsize Business, Commercial and Industrial and Multi-Family Programs. You are a valued partner and have helped our customers save 2,491,451 therms and \$2,285,395 in rebates.

As you may know, our energy efficiency programs are designed to be delivered over a four-year period and our budgets are defined by Illinois Legislation. Our current four-year cycle is ending December 31, 2021; as such, we are managing our budgets closely to end the year. Additionally, we are very excited to be making preparations to kick-off our next four-year cycle, which begins January 1, 2022.

Prescriptive Incentive Changes: Multi-Family, Small Business and Commercial and Industrial

- . Effective August 1, 2021, the following updates will be reflected on the 2021
 - Incentive no longer offered for steam trap testing
- Caps on boiler tune-ups reduced to \$1,000. . The updated application will be available on the Trade Ally website, peoplesgasnorthshoregastradeally.com, soon.






Phase 4 Planning

- Plan 4 (2022-2025) was approved on July 22, 2021
- Peoples Gas and North Shore Gas released four RFPs on April 16, 2021:
 - ✓ Residential and Income Eligible Program Implementation
 - ✓ Business Program and Research & Development Implementation
 - ✓ Portfolio Administration
 - ✓ Regulatory Support
- RFP process is ongoing and we expect to notify bidders of selections in early September
- Joint program planning discussions being held with ComEd, Nicor Gas and Ameren
- Participating in joint MDI Research RFP with ComEd and Nicor Gas
