#### **Illinois Evaluation Coordination**


#### **Coordination Process**

- Monthly coordination call
- Ad hoc meetings and discussion
- Participation in SAG and TAC Working Groups
- Collaboration on statewide research efforts

#### **Key Outcomes**

- Collaboration:
  - Advanced thermostat impacts
  - Voltage optimization impacts
  - Behavioral persistence
  - COVID-19 effects on evaluation
- Statewide research:
  - Compressed air EUL (Guidehouse)
  - Advanced thermostat customer preferences (Opinion Dynamics)





- Impact evaluation
  - We complete impact evaluations annually for all major portfolio programs
  - We support utilities in pilot development to ensure evaluability, and conduct evaluations as needed
- Net-to-gross research
  - We conduct net-to-gross research at least once per cycle for all programs unless there are extenuating circumstances (e.g. program is discontinued)
  - More frequently, if needed:
    - Market changes
    - Highly impactful programs



#### Process evaluation

- We regularly complete a core set of process evaluation activities (e.g., review of program materials, interviews with program staff, and participation analysis)
- Additionally, we regularly conduct more detailed process evaluations tailored to specific programmatic questions
- Market research
  - We complete market research studies on an as-needed basis and as evaluation budgets allow
  - Focus from utilities and SAG on specific topics is a major driver in determining if market research tasks need to be completed



- Other topics
  - We support a wide range of other activities in Illinois
  - Most notably over the past cycle, we have been researching non-energy impacts (NEIs) associated with utility programs
    - This includes annual quantification of economic and employment impacts from utility programs
  - We conduct effective useful life (EUL) research to support the IL-TRM
  - We conduct verified cost-effectiveness analysis annually
  - We review gas utility adjustable goals on an annual basis
  - We support SAG and utility consideration of market transformation



#### **Evaluation Research and IL-TRM**

- We design and conduct evaluation activities to support updates to the Illinois Technical Reference Manual (IL-TRM) wherever possible, and TRM research is a significant part of evaluation budgets
- When developing evaluation plans each year, we consider the evaluation priorities list for the IL-TRM (maintained by VEIC) and how evaluation activities can address these items
- Based on our research, we submit workpapers to the Illinois TAC that support TRM updates
- We also participate in TAC and working group discussions to inform TRM development and support VEIC and other stakeholders

#### **Discussion Topics**


- 1. Opportunities for more integration of EM&V work across utility service territories.

  - b) Should there be any dedicated shifts in the type of research conducted by evaluators?

## **Evaluation Emphasis**

- The primary objective of Illinois portfolio evaluations is to verify net program energy savings for compliance purposes
- Secondary objectives are:
  - To support impact verification (e.g. TRM updates)
  - Program improvement to produce more beneficial results for Illinois ratepayers (e.g. process research, market research, NEI/peak demand research)
